AGREEMENT

As a condition of being considered for the extension of credit on an open account by One Planet Catering, the Applicant promises and agrees as follows:

1. Credit Information. The applicant represents and warrants that the credit information provided herein is true and correct on the date this Agreement is signed.
2. References. The applicant authorizes One Planet Catering to contact any trade references and financial institutions listed herein, and further authorizes each of the references to provide such information and/or documents requested by One Planet Catering from time to time.
3. Payment. The applicant promises to pay their account balance now existing or hereafter incurred pursuant to the credit terms of One Planet Catering as they exist now and as they may be amended from time to time. If however, this account is not paid as agreed, the Applicant agrees to pay, in addition to the amount due, finance charges of 2% per month (24% per annum). If the Applicant's account becomes more than 30 days past due, the Applicant agrees to ship on a prepaid basis, without notice.
4. Attorney's fees and costs. In any litigation between One Planet Catering and the Applicant relating to the Applicant's account, the losing party shall pay the prevailing party's reasonable attorney's fees and all costs and expenses expended or incurred by the prevailing party in connection with such action, and the amount thereof shall be included in any judgment entered.
5. Applicable laws and venue. This agreement shall be governed by and subject to the laws of British Columbia and any action between One Planet Catering and the Applicant regarding the Applicant's account shall be litigated in the appropriate court in Vancouver, BC
6. Modification. This Agreement may not be modified or amended except in writing.
7. One Planet Catering and the Applicant agree that this Credit Application may be executed and returned by fax or e-mail and shall be a binding agreement in fax, e-mail or original form.
